**We guarantee this puppy to be in sound health and free from communicable diseases at the time of sale and for the following seven (7) days. The seller will replace a puppy found to be in poor health by the buyer's veterinarian.**

### HIP GUARANTEE -- ORTHOPEDIC FOUNDATION FOR ANIMALS INC. (O.F.A.):

We guarantee the puppy's hips will be O.F.A. certifiable at two years of age. It is the buyer's responsibility to meet the following requirements to enforce this guarantee:

- (1) Have hips x-rayed before dog is twenty-eight (28) months old. (Note: Dog must be permanently identified i.e. microchip or tattoo.)
- (2) Submitted the film to O.F.A. for evaluation immediately.
- (3) O.F.A. is the sole judge of hip quality.
- (4) Seller is to receive a copy of the O.F.A. written report and x-ray in a timely manner.

Seller will replace a dog found dysplastic by O.F.A.

### EYE GUARANTEE:

We guarantee the eyes will be free of PROGRESSIVE RETINAL ATROPHY (PRA) at two years of age. It is the buyer's responsibility to meet the following requirements to enforce this guarantee:

- (1) Have the eyes examined by a Veterinarian certified in ophthalmology before the dog is two years old.
- (2) Seller is to receive a written report in a timely manner.

Seller will replace a dog found to have PROGRESSIVE RETINAL ATROPHY.

### REPLACEMENT PROCEDURE UNDER GUARANTEE:

- (1) Seller's guarantee is to the original buyer only.
- (2) Buyer must notify seller of any problem in a timely manner, i.e., within 30 days of diagnosis.
- (3) Buyer must provide a written statement by a licensed veterinarian.
- (4) Buyer may select a replacement dog from any seller breeding of comparable or lesser value. If a higher valued dog is chosen, the buyer must pay the difference in value.
- (5) The dog and the American Kennel Club Registration papers, properly endorsed to the seller, shall be returned to the seller.
- (6) Transportation and/or freight charges are the responsibility of the buyer for both the returned dog and the replacement dog.
- (7) The seller reserves the right to return the purchase price instead of replacing the dog.

**ARBITRATION: Any controversy or claim shall be settled by arbitration using the rules of the American Arbitration Association.**
