**BREEDING CONTRACT**

**STUD SERVICE** is available to **APPROVED BITCHES** only. Approval is at the discretion of the stud dog owner.

- (1) **HIP JOINTS** must have an **OFA** evaluation of **EXCELLENT, GOOD, or FAIR**. For females under two years of age, a current hip X-ray with a **written Veterinarian's evaluation of "normal for age."**
- (2) Provide shot records for **RABIES, DHLPP, BORDETELLA**, and a recent negative **BRUCELLOIS** test.
- (3) Provide a copy of the **AKC Registration** and a copy of the **pedigree**.
- (4) Owner **warrants** the female is healthy, sound, and free of infection and disease and is not vicious.

**BOOKING FEE: \$100.** The non-refundable booking fee is due with the reservation of a **STUD DOG**. Make your booking in advance to avoid disappointment. Notify Kennel immediately when the female comes in season.

**STUD FEE: \$500.00** or the price of the first pup sold, whichever is greater. The booking fee is part of the stud fee. The balance of the stud fee is payable when the LITTER REGISTRATION APPLICATION is signed by the stud dog owner. Any extra fee is due when the pups go home. Stud fee for small litters: No puppy: a free repeat booking, one puppy: the booking fee, two puppies: \$200, three puppies: \$300, four puppies: \$400.

**BOARDING: \$10.00** per night. **DELIVERY to and PICK-UP from the kennel** is the responsibility of the owner.

**VETERINARY EXPENSES** are the responsibility of the owner **including Artificial Insemination if required**.

**TRANSPORTATION CHARGES: \$40.00 per hour** for airport or veterinarian pick-up or delivery.

**DEWCLAWS:** The litter owner agrees to remove the dewclaws when puppies are three to five days old.

**LITTER REGISTRATION APPLICATION:** The litter and stud dog owners agree to prepare and send the Litter Registration Application to AKC with the appropriate fee within ten (10) days of the birth of the puppies.

- PUPPY SALES:** The litter owner agrees to:
- (1) **Sell** the puppies direct to the purchaser.
  - (2) Specifically agrees **not** to sell puppies through pet stores, feed stores or other retail outlets.
  - (3) Have the puppies examined by a Veterinarian; have puppy's first shots and worming.
  - (4) Provide buyers written shot and worming records, a Bill of Sale, and an AKC Registration application.

**SPECIAL CIRCUMSTANCES:** \_\_\_\_\_

**The Owners of the Dam and Stud assume all risk of loss or damage and will insure at their discretion. If the Sire or Dam dies, or becomes unfit, we will return the booking fee and the contract shall be void. The parties shall not assign or transfer this agreement without the consent of all parties.**

**ARBITRATION:** Any controversy or claim shall be settled by arbitration using the rules of the American Arbitration Association and California State laws.

**THIS BREEDING CONTRACT CONTAINS THE ENTIRE AGREEMENT BETWEEN THE PARTIES. BY SIGNING THIS DOCUMENT, DOG OWNERS WAVE ALL OTHER RIGHTS AND REMEDIES.**
